REGULATIONS

- 1. The Wild Child's Reserve is an unusual offer for children carried out by the SZTUCZKA Studio Centre for Culture in Lublin in the framework of the Citizens' Budget of the City of Lublin.
- 2. The activity is aimed at children from 3 to 15 years of age. At the same time, we distinguish the division of the area into:
 - Buffer zone for children under 7 years of age (children can stay here only under the care of parents and guardians) Strict Reserve for children over 7 years old (there are only children, Playworkers and Organizers).
- **3.** The aim of the activity is to enable Participants, that is children, to create a space for independent action, to undertake creative activities and to create a natural co-operation in the peer group.
- 4. The reserve operates from May 12th October 28th, 2018 during the opening hours:

DURING THE SCHOOL YEAR

- Mondays closed
- Tuesday Friday 3.00 pm 7.00 pm
- Saturday-Sunday 10.00 am 6.00 pm

JULY - AUGUST

- Mondays closed
- Tuesday Sunday 10.00 am 6.00 pm
- 5. Definitions:
- **a)** Playworkers in the Reserve are adult natural persons (previously trained as part of the Playworking course) conducting permanent workshops taking place in the Reserve. They create conditions for children, provide construction materials and tools, supervise the safety of activities, provide guidance and, if necessary, help.
- **b)** The Participant is a minor natural person aged from 7 to 15 years using, on the terms set out in these regulations, submitted by the parent or guardian in the Child's Application Form, who has read the Honorary Code that is in force in the Reserve and is obliged to comply with it.
- c) The Wild Child's Reserve is an action organized by Pracownia SZTUCZKA to temporarily provide Participants with the natural conditions of development harmoniously with nature and their peers.
- **6.** The condition for accepting the Participant into the Reserve is the acceptance of the Regulations and filling in by the parent / legal guardian of the "Child's Application Form"
- **7.** Activities within the framework of the Reserve are held in the garden near the church of St Paul's Holy Conversion at Dolna Panny Marii street.
- **8.** Parent / legal guardian of children over 7 years of age can bring and take the child in person or familiarize them with the way to the Reserve, with special regard to street crossings, which a child over 7 years of age can take back on its own.
- **9.** Parent / legal guardian of children under 7 years of age is obliged to bring and take the child in person as well as look after him in the Buffer Zone.
- **10.** The Participant is obliged to report his arrival to Playworkers immediately after coming to the Reserve.He is also obliged to report his will to leave the Reserve.
- **11.** The parent / guardian is obliged to leave the contact telephone number and allow unrestricted contact with him during the opening hours of the Reserve.
- **12.** The parent / legal guardian is obliged to inform in the Child's Application Form about any ailments or diseases of the child, whose knowledge may affect the quality of care provided.
- 13. The organizer is not responsible for valuable items lost or damaged by the Participants during the activity.
- **14.** The parent / legal guardian is responsible for any damage caused by the Participant in the Reserve's area.
- **15.** Participants of the Reserve have the right to: participate in all activities provided for in the programme (adequate to their age), use all attractions, devices, equipment and materials available to them, submit comments and proposals.
- **16.** Participants of the Reserve are obliged to: follow these Regulations, follow Playworkers' orders, avoid behaviours that may jeopardize themselves or others, not to leave the Reserve without prior notice to the Playworkers, treat other Participants, workshops leaders and Playworkers with respect, respect their work, property and other property rights of other persons, not to use any means not allowed by law for children.
- **17.** In the event of non-compliance with the obligations described above, the Parent / legal guardian may be asked by the Organizers for an earlier or immediate withdrawal of a child who does not meet the conditions for participation.
- **18.** The Organizer undertakes to make every effort to create conditions for an attractive and safe form of activity by providing appropriate materials, tools and trained personnel in the field of Playworking, first aid and health and safety.
- **19.** The Organizer informed all public services: police, fire brigade and municipal police about the date and nature of the event.
- **20.** The organizer, according to the guidelines of the Roads and Bridges Management, sets a safe way on the street to the location of the Reserve and ensures appropriate marking.
- 21. Use of the Reserve is free of any charges. No meals are provided in the framework of the Reserve.
- 22. The event is covered by insurance as part of the programme activities of the Centre for Culture in Lublin.
- 23. The Organizer reserves the right to make changes to the programme of activities and these regulations.
